Individually or collectively referred as "Institution/s"

**Where As:**

Both the Institutions are engaged in the process of education through various courses under various permissions of Savitribai Phule Pune university norms and rules and regulations of University Grant Commission (UGC). In order to have joint venture as under, which might lead in the future to the establishment of one or more collaborative agreements for research and academic cooperation and for the delivery of joint programs in the various areas.



This MoU is made as a gesture of goodwill between the two institutions that has the potential to progress in the following areas of cooperation.

**The objectives of this joint –program are to:**

- a)Support research and education of the highest academic quality .The focus of the program would be initially in the areas of Health related Research and education that synergize RJSPM'S ACS ,College Landewadi ,Bhosari,Pune and second parties strengths .
- b)Provide opportunities for students to enhance their exposure and educational experience and to acquire competitive advantages for their future career development in a global environment by updating their knowledge through research methodology.
- c)Support strong collaborative research efforts in the specified areas of health research and education that are important to second party and RJSPM'S ACS ,College Landewadi ,Bhosari,Pune.
- d)Provide advance techniques and experience for the students and faculty that will prepare them to work in the area of Health Research and Education and related professional and academic communities ,which would be beneficial for the society at large.
- e)Engage resources from RJSPM'S ACS ,College Landewadi ,Bhosari,Pune and second party ,as well the Indian and implementing agencies that will strongly support such a joint program.
- f)Enhance the profile of collaborative research and education in Health Research and Education within foreign and Indian research communities.
- g)Share Knowledge by learning and teaching including development of programs leading to academic and research awards ,Exchange of academic information and material appropriate.

**ARTICLE I: PURPOSE:**

1.1.1 RJSPM'S ACS ,College Landewadi ,Bhosari,Pune and second party here by entering into this "MOU " to explore the broad range of potential educational and research collaborations for the mutual benefits and interest of imparting education at large ,of the





respective Institutions ,with intent of social orientation for helping the institution at large by use of interaction of sharing knowledge in order to discover Nature and its relatives and the different techniques by way or research methodology.

1.1.2 To Promote interest interested in teaching activities of the respective Institution.

1.1.3 The two participating institutions intend to explore collaborations aimed at meeting a demand for developing professionals who can successfully manage in the new global economy, suggest the remedies for disasters or the problems faced in the day to day activities socially.

## **ARTICLE :II: IMPLEMENTATION OF GOALS TO BE ACHIVED :**

A. **Joint goals** :In furtherance of these objects ,the following activities will be the focus of activities under the MOU :promote social exchanges by inviting faculty and staff of the either institutions to participate in a variety of teaching activities and professional development.

### **1. Faculty Centric programmes:**

Object: Opportunities will be explored enabling faculty from both institutions to be deputed at the partner institution for the purposes of lecturing, conducting research and otherwise developing their academic skills. Such programs to be greatest extend possible, may be conducted on a reciprocal basis , providing commensurate opportunities for the faculty of both Institutions.

### **2. Student Centric Programmers:**

- a. Organize symposia seminars, visiting lecturtes, Video conferencing and telephonic problem solving discussion conferances, short course and meetings
- b. Carry out continuing education programs and exchange information pertaining to developments in teaching and student development at each Institution

### **B. Joint Programs:**

The Institutions will investigate development of an articulated curriculum, culminating in a certificate program that might be jointly offered by Second Party and RajmataJijau Arts, Commerce and Science College, Landewadi, Bhosari.

### **C. Research Collaboration:**

Joint research activities may be encouraged and supported where the mutual interests and expertise of both Institutions may be furthered.

## **ARTICLE III :WORKABILITY AND EXECUTION PART:**

### **I. COORDINATORS AND SUB-COORDINATORS:**

There shall be one Coordinator to implement the actual relationship amongst the Institutions and the Coordinator may take help from respective sub-coordinators from each department of respective Institution to oversee and facilitate the implementation of this Agreement.

**Responsibilities of the Coordinators**, working with other appropriate sub-coordinators at the respective Institution, shall be:

- To arrange for the meetings communications and the minutes of the discussion for scheduling the programs in order to
  - to promote academic collaboration at both faculty and graduates students levels;
  - to act as principal contacts for individual and group activities and to plan and coordinate all departmental activities for which cooperation with the partner Institution is desired;
  - to distribute to each Institution, research information about the faculty, facilities publications, library materials and educational resources of the other Institution and
  - if deemed desirable, to meet periodically to review and evaluate past activities and to work out new ideas for future cooperative agreements.



### **II STAUTS OF AGREEMENT TO FROM RELATIONSHIP:**

- This is general Agreement of Cooperation establishing relationship amongst the Institutions and shall be identified as the PARENT DOCUMENT of any program agreement executed between the parties.
- Future agreements concerning any program shall provide details concerning the specific commitments made by each Institution and shall not become effective until they have been reduced to writing and executed by the duly authorized representatives of the respective universities.

- The scope of the activities under this agreement shall be determined by the funds regularly available at both Institutions for the types of collaboration undertaken and by financial assistance as many obtained by either Institution from external sources, which shall be reflected by another actual respective scheduled programmes agreement/s.
- No specific financial commitment by either party is to be implied from this agreement.

### **III .PERIOD OF THIS AGREEMENT:**

This Agreement shall be operative on the day of signing by both the Institutions and shall be effective for two years, thereafter. However, it is further agreed that the cooperative and planning activities undertaken under this agreement will be reviewed and evaluated on an annual basis. Any extension (or modification) of this MOU will require a written agreement or amendment to this MOU.

### **IV .TERMINATION CLAUSE:**

- a. Either party may by giving **Two Months written** notice, in advance, to another party may terminate this relationship; however on-going programmes will not have any effect by this termination, till completion of those on-going programmes.
- b. Termination shall be without penalty. If this agreement is terminated, neither the Institution shall be liable to the other for any monetary losses which may result.



### **V.RESTRICTIONS:**

Either Institution shall not use the name of another Institution thereof, or use logo or insignia of or otherwise identify another Institution thereof, in any form of publicity or disclosure without the prior written consent of either Institution, which consent may be withheld or granted

### **VI. IMPLEMENTATION OF RULES AND REGULATIONS:**

Host Institutions shall have responsibility to abide by the rules and regulations with the help of another Institution for abiding rules and regulations of Host Institutions.

## **VII.CONFIDENTIALITY CLAUSE:**

That information which is shared between both Institutions shall be kept under strict confidentiality and must be preserved and both the Institutions shall be under strict obligation not to share that confidential information even after termination of relationship under this agreement.

## **ARTICLE IV : INDEMINIFICATION CLAUSE:**

The both the Institutions herein undertakes to indemnify and keep always indemnified to any acts and cause and consequences of such acts, which adversely affects to the other party herein while implementing this MoU.
